



1. Overview

5. How we use collected information

7. Sharing your personal information

We strictly do not sell, trade, or rent Users' personal identification information to others or any third parties.

8. Law and harm

9. Data Retention: We retain customer information for as long as necessary to provide our services or as required by law. We may also retain customer information for our legitimate business purposes, such as fraud prevention, dispute resolution or any necessary reasons.

10. Your Rights: Customers have the right to access, correct, or delete their personal information following section 8. and section 9. Customers may also object to the processing of their personal information or request that we restrict the processing of their personal information. Customers may contact us at any time to exercise these rights.
